





 - (D) Locking Latch (2 per)
 - (E) Support Strut
 - (F) Handle
 - (G) Height Adjuster-Strut
 - (H) Height Adjuster-Top Panel
- Back Panel/Side Support Assembly
 - (K) Back Panel-Driver
 - (L) Back Panel-Passenger
 - (M) Side Panel-Driver
 - (N) Side Panel-Passenger
 - P Stabilizer Latch (Upper/Lower)
 - (R) Retaining Strap (2 Per)
 - S Height Adjuster-Side Panel (2 Per)








- (1) Open Top Panel Assembly **(A)**.
- (2) Layout Back Panel/Side Support Assembly (J).







IMPORTANT: Ensure Upper and Lower Stabilizer Latches are securely installed to prevent possible buckling.



- (1) Push Back Panel/Side Support Assembly (J) into position in truck bed centered side to side.
- (2) Set Top Panel-Driver **(B)** onto Side Support-Driver **(M)** and over Back Panel- Driver **(K)** as shown.





- (1) Position Top Panel-Passenger (C) onto Side Support-Passenger (N) and over Back Panel-Passenger (L) as shown.
- (2) Push down on center hinge ensuring ends of Top Panel Assembly **(A)** are firmly underneath truck bed sidewall channels.






- Swing down Support Strut (E) and center Top Panel Assembly (A) over Back Panel/Side Support Assembly (J).
- (2) Push/engage Support Strut (E) through slot in Back Panel/Side Support Assembly (J).








(1) Adjust Height
Adjuster Strut (G)
as required to
ensure Top Panel
Assembly (A) is
level fore and aft
relative to the truck
bed.



- (1) Swing Side Panel– Driver (M) inward to allow access to Height Adjusters– Top Panel (H) as shown. Ensure Height Adjuster– Side Panel (S) is in uppermost position resting on rib of truck bed floor.
- (2) Adjust Height Adjusters- Top Panel (H) upward until snugly engaged underneath truck bed side wall channels.
- (3) Repeat above steps for Passenger Side.







- (1) Swing Side Panel– Driver **(M)** outward to truck bed side wall as shown. Adjust Height Adjuster Side Panel **(S)** ensuring snug fit between truck bed side wall channels and bed floor.
- (2) Route Retaining Strap **(R)** securely in slot between truck bed floor and tailgate.
- (3) Repeat above steps for Passenger Side.




IMPORTANT: Retaining Straps (R)) must be securely attached to the Side Panels (M) and (N) and routed between the tailgate/truck bed slot to prevent possible drift toward the truck cab.

- Ensure Pickup Tuck is seated rearward in truck bed (Top Panel end details are snug against truck bed sidewall channels).
- (2) Flip-up locking latches (D) on top panel in upright position and close the tailgate.





(1) Check that Top Panel Assembly (A) is flush with tailgate. This will reduce potential for air backflow to push the unit forward to cab.



WARNING:

ADULT ASSEMBLY REQUIRED

- · Do not put pets in cargo compartment
- · 300 lb. maximum load
- Ensure both upper and lower Stabilizer Latches are securely installed to prevent possible buckling.
- Retaining Straps (R) must be securely attached to the Side Panels (M) and (N) and routed between the tailgate/truck bed slot to prevent possible drift to-ward the truck cab.
